Educational-professional program “Accounting and Taxation” for the first (bachelor’s) level of higher education in the specialty 071 “Accounting and Taxation” in the field of knowledge 07 “Management and Administration” has been developed and presented by the Department of Accounting, Analysis and Auditing of Yuriy Fedkovych Chernivtsi National University. The program determines the objectives, characteristics and peculiarities of the learning process, its general and professional competencies, learning outcomes; identifies the content of the educational components and the interconnection between them; contains the assessment forms; describes the resource support; confirms the validity of the academic mobility principles. All this gives an opportunity to receive a comprehensive idea of the features of the educational process.
